If you are a student in F-1 status requesting a SEVIS Transfer Release Form from Elmhurst University you must complete Section 1 and give the form to your Designated School Official (DSO)/International Student Advisor to complete Section 2.

Please submit a copy of your most recent I-20 along with this completed form to tony.marotta@elmhurst.edu

You must complete a SEVIS Transfer Release Form from Elmhurst if you already have F-1 status and are:

- Currently enrolled at or recently graduated from a U.S. school
- Currently in your period of Optional Practical Training (OPT) or recently completed your OPT

Note: You must request the transfer of your SEVIS I-20 record from your previous school to occur **within 60 days** of completion of your studies or your OPT.
